Main Dashboard:

- Upon entering the dashboard, you will land on this following page which includes 1) main visualization area separated into 4 sections, 2) filters, 3) navigation to the different tabs.



Sub-Screens:

- To move to another screen, press the desired tab on the top of the page.
  - You will be directed to the relevant tab.
- Adjusting the filters on that tab will create an updated visualization on that tab.
- To reset filters, press on the "reset" button on the top right hand of the filter pane

Some FDA approval dates were also before patent grant – we may need to drill into these data entries for an understanding whether it is real or data artifacts.

2) Number of applications by filing year: This tab shows the trend of patent filing with time, also drilling into trends of CPC-based technology category or DNA, RNA or Protein Sequence technologies.

3) Type of patent applications: this tab summarizes that proportion of patent applications represented by "drugs and chemical" and "diagnostics and devices", versus the other categories, throughout history of the data. By selecting different "filing date" range to the right, one can observe the dynamics in changing proportion of categories.



4) FDA ingredient by CPC inventive by Manufacturer: this tab visualizes the FDA approved "ingredients" vs CPC inventive codes. Only patents with FDA approval were selected. Color was also added to allow drill down into manufacturers.
