## SHOW CAUSE ORDER

To the above-referenced respondents:

The United States Patent and Trademark Office (“USPTO”) has evidence that [REDACTED] (collectively, “Individual Respondents”) filed over one thousand trademark submissions on behalf of others without the requisite qualifications to represent others before the USPTO in violation of the Rules of Practice in Trademark Cases before the USPTO. Based on their email addresses of record, and those associated with their USPTO.gov accounts, the USPTO further has evidence to believe that the Individual Respondents were acting on behalf of Trademark Counter, Apex Trademark, Trademark Centric, Trademark Bolt, and the individuals and entities doing business as Trademark Counter, Apex Trademark, Trademark Centric, and Trademark Bolt (collectively, “Company Respondents”). Together, the Individual Respondents and the Company Respondents (collectively, “Respondents”) are engaging in the unauthorized practice of law and providing false, fictitious or fraudulent information in at least 1,000 trademark submissions to the USPTO, including owner email addresses and signatures, with the intent to circumvent the USPTO’s rules and deceive the USPTO. See Exhibit A (list of affected applications).

Protection of the integrity of the U.S. trademark register is of the utmost concern to the USPTO because the register is a reflection of trademarks actually used in commerce and its accuracy serves the critical purpose of avoiding needless costs and burdens to applicants, who rely upon its contents when choosing a mark. Providing false information in a trademark submission to obtain or maintain a registration undermines the integrity of

the trademark register, and those who provide false, fictitious, or fraudulent information are subject to sanctions.

The Director has authority to sanction relevant parties for trademark submissions presented to the USPTO in violation of USPTO rules and has delegated to the Commissioner for Trademarks the authority to impose such sanctions and to otherwise exercise the Director's authority in trademark matters. 35 U.S.C. § 3(a)-(b); 37 C.F.R. § 11.18(c); *see also In re Yusha Zhang*, 2021 Commr. Pat. LEXIS 2, at \*10, \*23-24 (Dir. USPTO 2021) (sanctions). The authority to issue administrative sanctions orders has been further delegated to the Deputy Commissioner for Trademark Examination Policy.

Based on the available evidence and the following considerations, the USPTO has made a preliminary determination that sanctions are warranted to address the violations of USPTO rules concerning signatures, certification, and representation of others, and violations of the Terms of Use for USPTO Websites. This order requires Respondents to show cause as to why the USPTO should not immediately take certain actions and impose sanctions pursuant to 37 C.F.R. § 11.18(c).

Should you wish to respond to this Show Cause Order, a response is required **by October 17, 2025** in order to be considered.<sup>1</sup> Individual and Company Respondents may respond to this Show Cause Order, as detailed at the end of this order.

## I. USPTO Rules and Requirements

All submissions to the USPTO in trademark matters are governed by U.S. trademark laws and the regulations governing practice in trademark matters before the USPTO, including rules concerning signatures, certification, and representation of others (collectively, "USPTO Rules"). *See generally*, 15 U.S.C. 1051 et seq.; 37 C.F.R. Parts 2, 11.

An application for registration of a trademark filed with the USPTO must be made by the owner of the mark or a person who has a bona fide intention to use the mark in commerce. *See* 15 U.S.C. § 1051. The application must be supported by a verified statement, signed by the owner or a person properly authorized to sign on behalf of the owner. 15 U.S.C. §§ 1051(a)(3), (b)(3); *see also* 37 C.F.R. §§ 2.33, 2.193(e). USPTO Rules require that all signed documents submitted to the USPTO in a trademark matter must be personally signed or entered by the named signatory. *See* 37 C.F.R. § 2.193; TMEP § 611.01(b). A person may not delegate the authority to sign trademark-related submissions, and no one may sign the name of another, electronically or otherwise. *See Zhang*, 2021 Commr. Pat. LEXIS 2, at \*13; *In re Dermahose Inc.*, Ser. No. 76585901, 2007 TTAB LEXIS 25, at \*9-10 (2007); *In re Cowan*, Reg. No. 1225389, 1990 Commr. Pat. LEXIS 24, at \*5-6 (Comm'r Pats. 1990); *see also* Trademark Manual of Examining Procedure ("TMEP") §§611.01(b)-(c), 804.04 (May 2025 ed.).

A party who presents a trademark submission to the USPTO is certifying that all statements made therein of the party's own knowledge are true and all statements made therein on information and belief are believed to be true. See 37 C.F.R. §§ 2.193(f); 11.18(b)(1). The party is also certifying that, "[t]o the best of the party's knowledge, information and belief, formed after an inquiry reasonable under the circumstances, . . . the paper is not being presented for any improper purpose" and "[t]he allegations and other factual contentions have evidentiary support." 37 C.F.R. § 11.18(b)(2). Thus, knowingly or negligently submitting a document that includes false signatory information, false applicant information, or false claims of use of (or intent to use) the mark in commerce for goods and services that the applicant is not actually offering (or lacks a bona fide intent to offer), violates 37 C.F.R. §§ 2.193(f) and 11.18(b)(1), and doing so without evidentiary support or with intent to circumvent the USPTO's Rules violates 37 C.F.R. § 11.18(b)(2). Violations of 37 C.F.R. § 11.18(b) may jeopardize the validity of the application or registration and may result in the imposition of sanctions under § 11.18(c), including termination of proceedings. 37 C.F.R. § 11.18(c)(5).

Signed declarations or verifications made in support of trademark submissions—such as applications, declarations of use, or registration maintenance documents—are relied upon by the USPTO when examining trademark applications, registering marks, and maintaining registrations. The information in these submissions, such as a party's claim of ownership of the mark, the goods and services in connection with which the mark is or will be used, claimed dates of use, claims of use or bona fide intention to use the mark in commerce, are all statutory prerequisites for obtaining registration. 15 U.S.C. §§ 1051(a), 1051(b), 1058(b). The USPTO relies upon the facts and averments in trademark submissions to determine the applicant's or registrant's right to initial or continued registration. See *Look Cycle Int'l v. Kunshan Qiyue Outdoor Sports Goods Co.*, Cancellation No. 92079409, 2024 TTAB LEXIS 289, at \*39 (2024) (citing *Nationstar Mort. LLC v. Ahmad*, Opp. No. 91177036, 2014 TTAB LEXIS 350, at \*4 (2014)); see also *Norton v. Curtiss*, 433 F.2d 779, 794 (CCPA 1970) ("With the seemingly ever-increasing number of applications before it, the [USPTO] . . . must rely on applicants for many of the facts upon which its decisions are based."). The public also relies upon the accuracy of these submissions in determining the relevant priority and scope of protection claimed.

All signed documents must comply with Rule 2.193 and therefore must be *personally* signed by the named signatory, including the personal entry of all electronic signatures.<sup>2</sup> See 37 C.F.R. §§ 2.193(a), (c), 11.18(a); TMEP §611.01(b) (May 2025 ed.); see also *In re Stelcore Mgmt. Servs., LLC*, 2025 Commr. Pat. LEXIS 3, at \*5-6 (Dir. USPTO 2025). A person may not delegate the authority to sign trademark-related submissions, and no party may sign the name of another. See *Zhang*, 2021 Commr. Pat. LEXIS 2, at \*10; *Dermahose Inc.*, 2007 TTAB LEXIS 25, at \*9-10; *Cowan*, 1990 Commr. Pat. LEXIS 24,

<sup>2</sup> In the relevant time period, the trademark electronic system forms allowed for two ways to sign a document electronically: 1) the signatory directly enters the signature in the signature field on the electronic form ("Direct Signature"), 2) the signatory receives an emailed link to the form, which allows them to enter their electronic signature in the signature field ("ESIGN-ON"). The trademark electronic system forms now also allow for electronic signatures entered using document-signing software, however, this method was not used in any of the submissions referenced in this order. See TMEP §611.01(c)(ii).

at \*5-6; see also TMEP §§611.01(b)-(c), 804.04. For example, a paralegal, legal assistant, or secretary may not sign or enter the name of an attorney or other authorized signatory. TMEP §611.01(b). A trademark submission that is signed by a person other than the named signatory, is improperly executed, and cannot be relied upon to support registration. See *Zhang*, 2021 Commr. Pat. LEXIS 2, at \*10; *Ex parte Hipkins*, Appeal No. 90-2250, 1991 Pat. App. LEXIS 14, at \*10-13 (BPAI 1991); *Cowan*, 1990 Commr. Pat. LEXIS 24, at \*5-6. A signature that does not meet the “personally signed” or “personally entered” requirements, see 37 C.F.R. §§2.193(a), (f), 11.18(a), “may jeopardize the validity of [an] application or registration.” 37 C.F.R. §2.193(f). Thus, these signature requirements are not merely technical in nature but rather are substantive.

All submissions to the USPTO in trademark matters are governed by the USPTO Rules. See, generally, 37 C.F.R. Parts 2, 11. Under these rules, only attorneys admitted to practice before the bar of the highest court of a U.S. state or jurisdiction may practice before the USPTO in trademark matters on behalf of others. 37 C.F.R. §§ 2.1, 2.17(a), 11.1, 11.14(a); see also 5 U.S.C. § 500(b).

Any individuals who are not U.S.-licensed attorneys<sup>3</sup> are not authorized to practice before the Office and may not (1) give advice to an applicant or registrant in contemplation of filing a U.S. trademark application or trademark-related document; (2) prepare or prosecute any U.S. trademark application, response, or post-registration maintenance document; (3) sign amendments to applications, responses to Office actions, petitions to the Director, or request to change correspondence information; or (4) authorize any other amendments to an application or registration. 37 C.F.R. §§ 11.5(b), 11.14(b).

Finally, an applicant or registrant is also required to provide and maintain a valid email address where the applicant can receive correspondence. See 37 C.F.R §§ 2.23(b), 2.32(a)(2). The email address is crucial to the proper administration of the trademark registration process because the USPTO uses the identified owner email for correspondence when a party is not represented by a U.S.-licensed attorney. See TMEP § 803.05(b). When an email address is provided that is not in fact the email address of the actual mark owner, an unauthorized party may receive correspondence from the USPTO.

## **II. USPTO.gov Terms of Use**

In order to access and file electronic forms and submit trademark documents to the USPTO, trademark applicants or their attorneys must register for and use a USPTO.gov account. Use of a USPTO.gov account and any other USPTO website or system requires users to agree to and comply with the Terms of Use for USPTO Websites (“Terms of Use”). See <https://www.uspto.gov/terms-use-uspto-websites>.

An individual who is not authorized to practice before the Office on behalf of others (or is not attorney support staff directly assisting an attorney), may make submissions through

a USPTO.gov account in application or registration records *only* on his or her own behalf as the individual trademark owner or on behalf of a juristic entity owner of which he or she is a partner, member, officer, or direct employee.

Under the Terms of Use, registration for and use of a USPTO.gov account is limited to the individual to whom the account is registered, and the registered individual is responsible for all activities occurring under that account and any sponsored accounts. The sharing of USPTO.gov accounts thus violates the Terms of Use.

Other breaches of the Terms of Use include use of a USPTO.gov account to submit, access, or alter information exceeding one's authority, which also violates 37 C.F.R. §§ 2.193(f) and 11.18(b). The USPTO can consider submissions filed in violation of the Terms of Use in connection with a trademark proceeding as a document submitted for an improper purpose in violation of Rule 11.18(b), and may strike, or otherwise not consider or give any weight to, such correspondence in accordance with the relevant USPTO rules. See 87 Fed. Reg. 432 (Jan. 5, 2022).

Furthermore, violations of the Terms of Use may result in immediate termination, suspension, and/or revocation of all related USPTO.gov accounts, particularly when the accounts are used to make submissions that are unauthorized under the regulations of the USPTO.

### **III. The Respondents' USPTO Rule Violations and USPTO.gov Terms of Use Violations**

The Individual Respondents are individuals identified by the names noted above and are connected to four USPTO.gov accounts as follows:

Despite the fact that the domains differ, these USPTO.gov accounts appear to be relatedly controlled because the email address [REDACTED]@trademarkcounter.com appears in at least one trademark filing made by each of the four accounts associated with the Individual Respondents. See Exhibit B (example filings in Ser. Nos. 97040357, 97178654, 97426845, 97442558.)

The Company Respondents are identified by the domains associated with the email addresses identified above. In addition, Company Respondents are identified by application owners who contacted the USPTO. See Exhibit C (representational correspondence from applicants who identify Company Respondents as responsible for preparing applications emanating from one of the four accounts associated with the Individual Respondents). Each domain either currently connects or previously connected

to a website offering trademark registration services, among other services. See Exhibit D (website printouts).

Although these websites suggest that the trademark services offered are provided by attorneys, no attorney information appears on Company Respondents' webpages. Further, applicant emails demonstrate that Company Respondents invented trademark registration requirements and filing fees not called for under USPTO Rules. See Exhibit C. They actively held themselves out as providing legal services, despite the lack of U.S.-licensed attorney involvement, and concealed their identities by listing fake addresses on their websites.<sup>4</sup>

USPTO filing records reveal that Respondents collectively submitted more than 1000 trademark applications in the names of hundreds of different owners with geographically diverse addresses, and that the applications and associated declarations in the applications were not personally signed by the individuals named. See Exhibit A; Exhibit F (showing representational application filing data). Based on available filing data, the USPTO concludes that Respondents electronically signed submissions using the "direct signature method," entering the names of hundreds of different individuals or entities related to the listed owners.<sup>5</sup> See Exhibit F. Further, these submissions originated from the same small number of computer networks despite the geographic diversity of the listed mark owners' addresses of record. *Id.*

Moreover, none of the names associated with the USPTO.gov accounts are attorneys or attorney support staff working under the direct supervision of an attorney. Thus, under USPTO Rules, the holders of the accounts could not sign or submit trademark documents on behalf of anyone other than the named USPTO.gov account holders, who are not applicants in any USPTO records. 37 C.F.R. § 11.5(b)(3); see *also* Exhibit A.

Respondents also made of record email addresses under their own control so as to intercept official USPTO correspondence, which is generally sent electronically. See Exhibit F (showing representational correspondence email addresses). Providing this false correspondence information is a violation of at least 37 C.F.R §§ 2.23(b), 2.32(a)(2), which require an applicant's valid email address for correspondence, and providing a false owner email address in an application for the purpose of intercepting USPTO correspondence for the applicant constitutes submitting a document for an improper purpose under § 11.18(b).

All of the evidence discussed above shows that Respondents were aware of the impropriety of their conduct in filing these applications, and that they devised methods to conceal their involvement and advance submissions for an improper purpose, including

<sup>5</sup> The "direct signature method" refers to when an electronic trademark submission is signed directly within the trademark electronic filing system form and has not been sent to a third party for signature.

to disguise that Respondents were representing trademark applicants before the Office without the involvement of licensed U.S. attorneys. In Respondents' efforts to conceal their identities, they entered false signature information, information which is material to the Office's determination to issue a registration. Moreover, Respondents' conduct demonstrates a pattern of making false material representations of fact in connection with application proceedings with an intent to deceive the USPTO into believing that application requirements were satisfied. See *In re Bose Corp.*, 580 F.3d 1240, 1243, 91 USPQ2d 1938, 1939 (Fed. Cir. 2009) ("Fraud in procuring a trademark registration or renewal occurs when an applicant knowingly makes false, material representations of fact in connection with his application."). Such actions show an intentional effort to mislead the USPTO regarding Respondents' authority in these trademark proceedings, which supports a finding that such false material representations of fact were made knowingly, willfully, or at the very least, with reckless disregard. *Look Cycle*, 2024 TTAB LEXIS 289 at \*34 (explaining that fraud can be demonstrated by knowing violations, or those undertaken with reckless disregard for the truth).

#### **IV. Show Cause Requirement**

In determining appropriate sanctions, various considerations may be taken into account, including what is needed to deter the conduct by the party and by others and whether: the improper conduct was willful, the conduct was part of a pattern of activity or an isolated event, the conduct infected an entire application or one particular submission, the party has engaged in similar conduct in other matters, the conduct was intended to injure, or the effect of the conduct on the administrative process in time and expense. 73 Fed. Reg. 47653 (Aug. 14, 2008).

Based on the foregoing, the USPTO has reason to believe that all applications and trademark documents filed via the above USPTO.gov accounts were filed in violation of the USPTO Rules and are invalid. The applications and documents were not properly signed, appear to have been submitted without Respondents making reasonable inquiry into the factual contentions contained therein, and contain false, fictitious, and/or fraudulent information. Available information also indicates that such submissions were filed with an intention to circumvent the USPTO Rules including, but not limited to, 37 C.F.R. §§ 2.11(a), 2.23, 2.32, 2.193, 11.14, and 11.18(b). In addition, USPTO records indicate that these submissions were made using the USPTO systems in contravention of the Terms of Use for USPTO Websites.

Because the information discussed above supports a finding that Respondents' actions violate the USPTO Rules, Respondents are hereby ordered to show cause why the USPTO should not enter the following sanctions:

- (1) Permanently preclude Respondents and any employee, agent, or anyone acting on behalf of Company Respondents from submitting trademark-related documents to the USPTO;

- (2) Strike or otherwise give no weight to all trademark-related documents submitted by Respondents or any employee or anyone acting on behalf of Company Respondents;
- (3) Remove correspondence information associated with Respondents and any employee, agent, or anyone acting on behalf of Company Respondents from the USPTO's database in all applications and/or registrations;
- (4) Deactivate any USPTO.gov accounts in which contact information related to Respondents appears, and take action to prevent Respondents from creating or activating further accounts;
- (5) Block future financial transactions from credit cards used to pay filing fees associated with the improper submissions and/or associated with Respondents
- (6) Terminate all ongoing proceedings containing submissions filed by Respondents or any employee, agent, or anyone acting on behalf of Company Respondents; and
- (7) Continue to strike documents, remove information, deactivate accounts, and terminate proceedings containing submissions later found to have been filed by Respondents or any employee, agent, or anyone acting on behalf of the Company Respondent.

#### **V. How to respond:**

The USPTO will consider your response in determining the appropriate sanctions. If you object to the USPTO imposing the sanctions proposed in the Show Cause Order, you must respond to this notice **by 11:59 PM Eastern Time on October 17, 2025**. To be considered, responses must be submitted in writing using the procedures for Respondents and Owners described below.

Any response or electronic communications submitted to the USPTO will be considered part of the public record and are not exempt from disclosure.

Respondents: A response must be submitted via email to [TMPolicy@uspto.gov](mailto:TMPolicy@uspto.gov).

Owners of application serial numbers identified in Exhibit A: If an applicant believes that its application was included in error in this show cause order and wishes to submit a response, the applicant's response must be submitted using the [Petition to Director](#) form available on the USPTO's website.

Your response must establish that you are authorized to take action on behalf of others under the USPTO Rules, and must include evidence corroborating any factual claims you make.



This order is issued without prejudice to the USPTO taking all appropriate actions to protect its systems and users from your continued improper activity, including issuing additional orders relating to other applications, or referring your conduct to relevant state and federal law enforcement agencies.

A separate notice concerning this order will be uploaded in each application file identified in Exhibit A and sent to the correspondence email address of record.

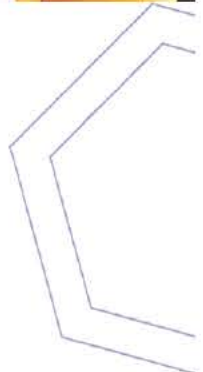

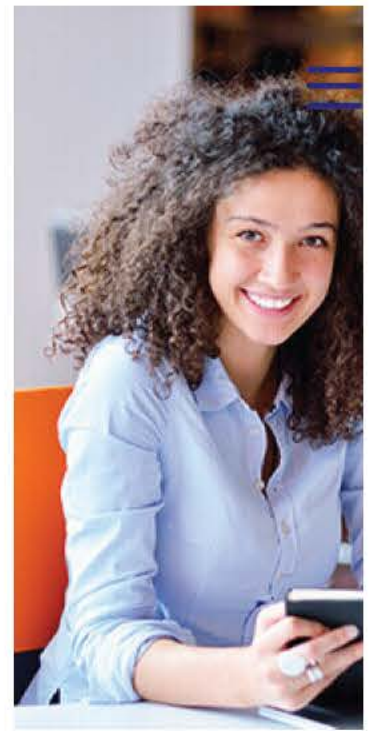

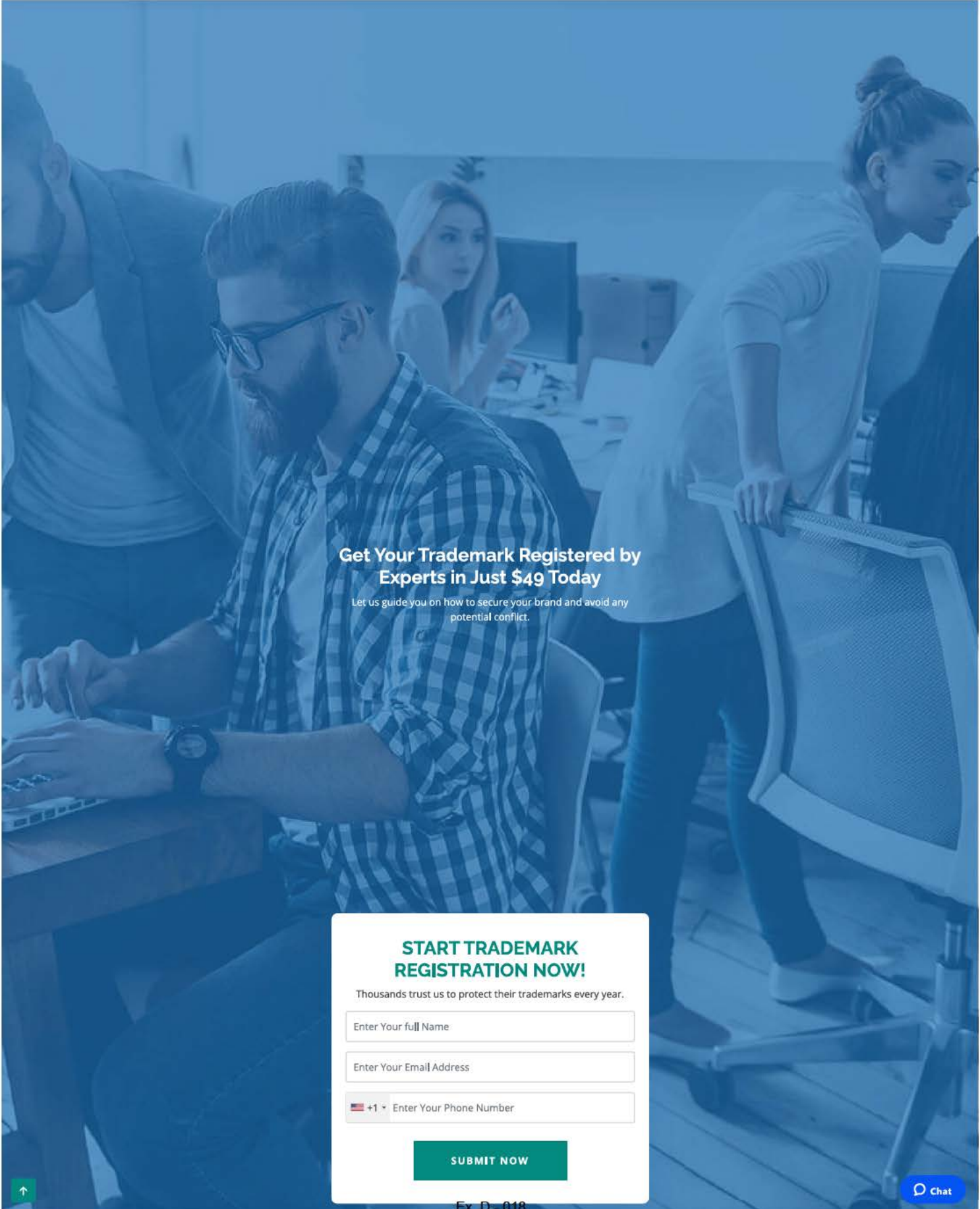
